This is in response to your request dated 8 November 2013, received in the Information Management Division of the Office of the Director of National Intelligence (ODNI) on 12 November 2013. Pursuant to the Freedom of Information Act (FOIA), you are requesting a copy of a “. . . **Trilateral Memorandum of Agreement (MOA) among the Department of Defense and the Department of Justice and the Intelligence Community Regarding Computer Network Attack and Computer Network Exploitation Activities, May 9, 2007.**”

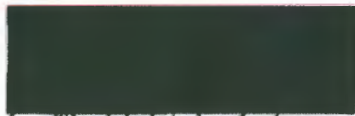
